No guarantee is made at time of sale regarding show, hunting, or breeding prospects of sold dog. The dog is sold as a pet, and no guarantee is made regarding monorchidism or other fertility problems.

This dog is guaranteed to be in good health, to the best of our knowledge at the time of this sale, and has had initial inoculations against distemper, parvovirus, parainfluenza, and received de-worming. The buyer has **(3) three business days** from the day of delivery in which to have the dog checked by a licensed veterinarian, and is urged to do. If the veterinarian finds the dog to be seriously ill, the cause of which is clearly hereditary in nature (this *does not* include the presence of parasites), return the dog along with the AKC Registration papers. Another dog of similar breeding will be given in exchange, or money returned if no other dogs are available at that time, provided a letter from the examining veterinarian is offered as proof of illness. It is agreed and understood that any exchange must be made within the three day guarantee period. The seller assumes no responsibility for this dog after leaving premises for medical expense (including veterinary exam), mortality, landlord's disapproval, allergic reaction to dog, disagreement with family, behavioral/training difficulties, mistreatment of dog, accidental poisoning or trauma to dog, re-growth of dewclaws or for any other reason.

This dog is also guaranteed to **26 months** of age, against any severe and/or life-threatening congenital heart, liver, kidney, or thyroid defects, cancer, seizure disorder or eye defect causing blindness within the first year of life. In addition, this dog is guaranteed, until 26 months of age, against severe crippling hip dysplasia. Should any of these defects occur, which are clearly hereditary in nature and seriously affect the dog's quality of life, return the AKC Registration papers and a letter from **two licensed** veterinarians confirming the defect(s) and a spay/neuter verification from your vet. A dog (puppy) will then be offered as a replacement of equal value (breeder's choice) when the next litter of comparative value is available. In the case of hip dysplasia, you must also submit copies of radiographs (x-rays) taken by two veterinarians which are specific and conclusive proof of severe hip dysplasia. Also, a statement from your two veterinarians that this dog has not and never has been overweight for it's bone structure, and no evidence that this dog was overstressed, or over exercised during this important growth phase. This is limited to a one-time replacement and no further guarantees are made. It is agreed and understood no money refund will be given. It is agreed by all parties that arbitration concerning this dog, contract or guarantee shall be made in the state of Virginia and that all shipping arrangements and shipping costs involved with returning or replacing a dog under the terms of this contract, shall be the sole responsibility of the buyer.

It is further understood and agreed that no warranty or representation has been made with respect to sold dog, except as set forth in writing in this agreement. This guarantee is valid only for the original owner and is non-transferable.
